## 2010 Hottenstein Reunion Picnic to be Sunday, June 13th, at the Hottenstein Mansion, Kutztown

The 74<sup>th</sup> Hottenstein Reunion, the family picnic gathering, will be held on Sunday, June 13, 2010 at Hottenstein Mansion, on Route 222, east of Kutztown, Pennsylvania. The Reunion will begin in the morning, with the catered picnic to be served at 1:00 PM. All are welcome.

We have again been invited by Dr. Robert Reynolds, and his family to the Mansion, which he describes as the home of the Hottenstein family. We will be the guests of Dr. Reynolds, his family, and the Historic Preservation Trust for Berks County, as the Mansion is their home. Dr. Reynolds is the curator of the Mansion.

In addition to visiting the Hottenstein Mansion, we will have the catered Family Picnic on Sunday at the Mansion. Arrangements are being made for a tent and shelter. This is a time when family members are able to visit, share experiences, and socialize. During this time, we will have our Reunion business meeting. Dr. Reynolds and his family will explain the home, period furniture, and Hottenstein artifacts displayed for the Reunion.

Dr. Reynolds is on the faculty of Kutztown University where he is the Freyberger Professor of

Dr. Reynolds will share new information on the extent of the Hottenstein influence in the area of the Mansion. In addition, plans for 2011 tours to Germany will be available. Park Ritter and others may share additional research information.

### **Historical Hottenstein Findings –**

By Park Ritter, Lancaster, Pennsylvania

In conducting research at the Evangelical & Reformed Historical Society, in Lancaster, several items of interest were found and are shared below:

Park Ritter located a marriage certificate for his 4<sup>th</sup> great grandfather, David Hottenstein, which reads:

I do certify that David Hottenstein of Maxatawny in Berks county, widower and Catherin Appel of Saucon in Northampton county were lawfully joined together in Holy Matrimony, the eleventh day of June in the year of our Lord, One thousand seven hundred and seventy-one. Given in Springfield Township, Philadelphia County ... Witness my hand and seal, Michael Schlatter, Minister of the Gospel.

Park further discovered that on August 20, 1751, Maria Catherina Hornecker married Johann Martin Appell in St. Paul's Church in Upper Saucon, Lehigh County. She was the daughter of Rudolf, who arrived in August 1747 on the ship, Vernon. Catherina is buried in the family plot in the cemetery on the hill across the road from the Hottenstein home. This helps to answer an age long question about this lady in the home.

Also found is a newspaper article that might explain why Jacob and Dorothea were not heard of between 1720 and 1727. It seems that they were indentured for that period of time, in Bradford County.

# SOME ACCOUNTS OF THE EARLY GERMAN SETTLERS OF BRADFORD COUNTY AND THEIR CONTRIBUTION TO HISTORY

Jacob Hottenstein arrived in the county in 1829. He was born in 1799 in Berks county, Pennsylvania. He had a family of nine children. Two of his sons died in southern prisons during the Rebellion. Mr. Hottenstein's great grandparents came from Germany in 1720. His great grandfather was sold for passage, and served seven years to discharge the debt. After he served his time out he saved money enough to buy seven pounds of tobacco, which article he traded to the Indians for 400 acres of land. This tract is still occupied by the Hottensteins, (1878) in Maxatawny Township, Berks county, Pennsylvania.

## **Contributions to the Historic Trust Directed to Mansion Projects**

In 2009, Reunion family members and friends contributed \$1,100 to the Historic Preservation Trust of Berks County in support of the Mansion restoration in response to the Reunion program for the Mansion.

In 2008, funds were focused on the restoration of the slate roof and interior support beams of the summer kitchen as a specific project proposed by Dr. Robert Reynolds and approved by the Trust.



Period slate tiles, gleaned from other buildings in the area, were used for the roof in the restoring the summer kitchen at the Hottenstein Mansion.

In 2009, the received funding was being applied to new cooper gutters and downspouts for the mansion and the kitchen ell.

Future projects include the restoration of the Dr's Office. This small building is now recognized as a unique and prime example of a rural doctor's office. With its historic equipment, it shows how health services were provided generations ago.

Restoration projects at the Hottenstein Mansion continue to need funding. Our contributions program assists with projects underway and planned to bring the Mansion and it's associated buildings back to their historic grandeur. Dr. Reynolds interest -- his dream -- in preserving and restoring the Mansion will be helped with our donations.

Special procedures are established for contributions from Hottenstein family members and friends to be directed to Mansion projects. Checks are to be separately payable to the "Historic Preservation Trust of Berks County" and may be sent with the reservation form included with this newsletter, whether or not attending the Reunion.

## 2009 Hottenstein Family Reunion Meeting Minutes June 16, 2009, At the Mansion, Kutztown, Pennsylvania

The reunion was hosted by Rob and Jeanette Reynolds at the Hottenstein Mansion in Maxatawny Township, Berks County, near Kutztown, Pennsylvania.

There were 53 people in attendance. The Old time Plow Boys again provided the tractor and wagon ride from the parking area approximately one mile from the mansion. In the mansion, displays of period items were set up; Dr. Rob Reynolds and his wife, Jeanette, explained historical features of the rooms and craftsmanship.

At 1:00 P. M. the dinner bell called everyone to a wonderful meal of baked ham, baked chicken legs, scalloped potatoes, candied carrots, string beans, with ice cream and strawberries for dessert. John Hottenstein, Jr. offered the blessing.

At 2:00 P. M. the business meeting was called to order, by Terry Schnure. He made comments about the graciousness of Rob and Jeanette Reynolds in hosting the Reunion and express the appreciation of all, in being able to see the Mansion.

## **2011 Tours of Hottenstein German Areas** and Europe

A 75th Hottenstein Reunion Anniversary tour strongly focused on the Hottenstein heritage in Germany is being planned for the Fall of 2011, to be tailored to the interests of those joining the trip, those who have yet to go to Germany and those who wish to go back. Planned as a 14 day trip, the tour is intended to be for a group with no more than 18 participants using small motor coaches to be able to stay at family run hotels and inns and dine at small local restaurants. Such traveling provides more local culture and flexibility. This tour includes a visit to the Hottenstein Church, near Wuppertal, Rhine River area, Heidelberg, Ittlingen, Black Forest area, Bern, Interlaken, Salzburg and Prague. This tour is proposed for late September to early October 2011, to take advantage of the low season rates.

A separate 22 day tour is being planned which will start in the Hottenstein area of Germany and be more extensive to include eastern Europe. This tour includes the Hottenstein Church, with an itinerary that includes Karlsruhe, the Black Forest area, Ittlingen, Regensburg, Prague, Berlin, Poland's lake district, Warsaw, Auschwitz, Krakow, Slovakian mountain and mining areas, Budapest, Austrian Alp area and Villach, Italian Dolomites, Italian lake district, Swiss Alps and Tasch, Zermatt, and Geneva. This tour is scheduled to be from July 14 to August 4, 2011.

The tours, respectively, are escorted by Joe and Joyce Hottenstein, who operate Travel Visions. Joe and Joyce have organized European Tours for 18 years. Many costs are included in the tour fee, while giving participants freedom to pursue interests in each location. The per person price for the 14 day 75<sup>th</sup> Anniversary Tour is estimated to be \$4000; the price for the 22 day tour is estimated to be \$5500. All prices are estimated to be on the high side, are based on 16 participants, and include airfare, accommodations, motor coach and driver, breakfast and dinner, admission to featured attractions, and tips. Final pricing will be lower if 18 participate, to be determined when information on participant numbers and tour options are assembled. If interested, a deposit of \$250 per person is required by July 1, 2010.
